



Shareholders accepted all motions at the 2019 AGM

Milan, Italy – April 2, 2019 – Newron Pharmaceuticals S.p.A. (“Newron”) (SIX: NWRN), a biopharmaceutical company focused on the development of novel therapies for patients with diseases of the central and peripheral nervous system, announces that shareholders approved all motions on the agenda of its shareholders’ annual meeting held in Bresso, Italy, today, including the approval of the Company’s financial statements as of 31 December 2018. Furthermore, shareholders appointed the statutory auditors under Italian law and the audit company, both for a three-year term. About 27.7% of Newron’s total capital of 17,845,345 shares were represented at the meeting.

Newron (SIX: NWRN) is a biopharmaceutical company focused on the development of novel therapies for patients with diseases of the central and peripheral nervous system. The company is headquartered in Bresso near Milan, Italy. Xadago® (safinamide) has received marketing authorisation for the treatment of Parkinson’s disease in the European Union, Switzerland, the USA, Australia, Canada, Brazil and Colombia and is commercialized by Newron’s partner Zambon. US WorldMeds holds the commercialization rights in the USA. Meiji Seika has the rights to develop and commercialize the compound in Japan and other key Asian territories. In addition to Xadago® for Parkinson’s disease, Newron has a strong pipeline of promising treatments for rare disease patients at various stages of clinical development, including sarizotan for patients with Rett syndrome and ralfinamide for patients with specific rare pain indications.
